Executive Summary

An overview of the initiatives + activities undertaken by METS to improve the global competitiveness + productivity of the Australian METS sector.

METS Ignited Mission

To strengthen Australia's position as a global hub for mining innovation and enhance the global competitive advantage of the Australian METS industry.

Vision

The Australian METS industry has an aligned, efficient and agile industry ecosystem with a high degree of collaborative, global leadership in innovation and a growing share of the global market.

History

METS Ignited Australia Limited is an industry-led, government-funded Growth Centre for the Mining Equipment, Technology and Services (METS) sector. Our objective is accelerating commercialisation of innovation, enhancing industry capability and workforce, growing exports and identifying regulatory reforms that can positively impact the sector. Major milestones since establishment have been:

- Develop and maintain the 10-Year Sector Competitiveness Plan as a relevant body of economic, business and technological knowledge for use by the sector and governments.
- Industry Collaboration Partner for Australia's premier Global International Mining and Resources Conference, IMARC.
- Deliver Queensland Government Work Program for METS SMEs' enhancement in both metropolitan and regional centres, and the expansion of offering these to other Australian states and regional centres.
- Establishment of the METS Collaborative Project Fund Program to facilitate Miner-METS-Researcher collaborative projects.





The 2018/2019 Year in Review

In 2018/2019 METS Ignited has been transitioning into a leadership role in driving co-ordinated outcomes for the sector.

As our Collaborative Project Funding, METS Accelerator programs and our Masterclass initiatives take hold, we see the significant growth opportunity for the Australian METS sector from the next wave of new digital and automation technology. In partnership with the Entrepreurs Program, Austrade, Industry membership organisation and supporting CRC bids for mining-technology CRCs in Australia, METS Ignited is moving quickly to ensure the sector capitalises on this opportunity. METS Ignited has prioritised the following key strategic areas of focus:

- Project Funds—Collaborative Industry-led Investment
- MasterClasses—Future Skills and Workforce
- Accelerators—Commercial Maturity for METS
- Clustering—Collaborative sustainable ecosystem
- International Markets—Coordination Program

METS Ignited has recognised that education, skills and the innovation ecosystem have to develop both from an industry specific domain capability as well as across sectors, and has been working in collaboration with the other Industry Growth Centres on how to balance the specific needs against the broader skills challenge facing the country.





Financial Overview

Revenue for the 2018-2019 financial year totalled \$8,198,508. Funding received from the Department of Industry, Innovation and Science totalled \$6,598,237 which included operating funds for the Growth Centre (\$3,500,000), grant funds for projects (\$3,000,000) and other allowances (\$98,237).

In addition funding of \$1,008,698 was received from the Queensland State Government for pilot programs, along with interest of \$209,579 and other revenue of \$23,994. In-kind revenue of \$358,000 was recognised for office facilities provided by the Queensland University of Technology along with a secondee from the Queensland Government Department of State Development, Manufacturing, Infrastructure and Planning.

Total Expenditure for the 2018-2019 financial year amounted to \$9,146,495 which included operating expenses \$2,783,316, discretionary project expenditure, \$1,331,592, project funds expenditure \$3,481,260, Industry Growth Network support \$199,006, Queensland pilot programs \$993,321 and in-kind expenditure (offset) \$358,000.

Carried forward funds at the end of the financial year amounted to \$13,412,846 which included \$11,518,078 preserved for projects of which \$4,409,927 are uncommitted.

The organisation is governed by a Board of respected industry leaders from across the METS sector.

Progress Report

METS Ignited's goal is to strengthen Australia's competitive position as a global hub for mining innovation and enhance the global competitive advantage of the Australian METS sector.

The four core objectives of the Industry Growth Centre is accelerating commercialisation of innovation, enhancing industry capability and workforce, growing exports and identifying regulatory reforms that can positively impact the sector.

Success will create more highly skilled jobs, grow exports, scale highpotential Australian companies and continue to expand the economic value generated by the METS sector. The strategy to achieve these objectives is to focus on the following activities:

- Project Funds Collaborative Industry-led Investment
- Masterclass Future Skills and Workforce
- Accelerators Commercial Maturity for METS
- Clustering Collaborative sustainable ecosystem
- International Markets—Coordination Program

In addition to these strategic priorities, METS Ignited continues to provide guidance and support for skills development, for research investment, (CRCs, CRC-Ps and ARCs), regulatory improvements, and evolving operationally to adapt its organisational design and structure to meet the changing needs of its stakeholders.





Project Funds

In 2018/2019 METS Ignited has been transitioning into a leadership role in driving co-ordinated outcomes for the sector.

The METS Ignited Collaborative Project Funds support industry-led projects to improve the productivity, competitiveness and innovative capacity in the METS sector. Further to the existing projects underway from Tranche I and II, during the 2018/2019 year an additional Tranche III of project funding was awarded, with eight mining supply organisation receiving \$4.1m in innovation funding from METS Ignited.

METS Ignited received 26 grant applications since July 2018, and awarded the funds to businesses specialising largely in robotics and automation, data analytics, data platforms, internet of things and business and professional services. The recipients are: Mineral Technologies, Premron, Austmine, Roobuck, Process IQ, AMOG and Mattigeaux. Recipients of the Collaborative Project Funds are required to secure equal or greater investment from an industry partner. As a result, the total value of these additional eight projects is \$11m.

Masterclasses

METS Ignited is focussed on enhancing the industry capability and workforce skills.

Through industry consultation it was identified that the sector would benefit from a series of specific training programs. The Masterclass series is a cross-ecosystem program collaboration between the Entrepreneurs Program (EP), METS Ignited and Austmine. In 2018/2019 the Masterclasses program was expanded to cover the various differing needs in both captical cities and regional centers. Two key programs, 'Winning More Business' and 'Workforce 2025' were devlivered in 15 different locations with over 200 attendees across the events.

The partnership network for the delivery expanded to include regional universities, regional industry ascociations in addition to the founding organisation. In the 2019/2020 timeframe the program will be further expanded to provide a range of delivery modes, from classroom, virtual, online and in situ training and development, expanding on the skills needs to address the next generation of industry opportunities.



Accelerators

In 2016, METS Ignited and the Queensland Government entered into an agreement to deliver a Work Program to identify the significant industry challenges and opportunities—community, customers and competitors look at the markets Commercialisation skills, Capabilities and Collaboration frameworks and develop a Roadmap and Sector Competitiveness Plan.

As part of building the skills and capability of the industry, it was identified that there was the need for a program to help small to medium-sized METS companies expand and grow their organisations. The initial accelerator pilots were held in Brisbane and Perth, and the success of the program was immediate.

In 2018/2019 this Queensland program was expanded to deliver workshops into the regions. Almost 100 participants from over 40 METS SMEs attended regional accelerators in regional centres including Rockhampton, Gladstone, Mackay and Toowomba. They were locally run, with a mix of Mining and METS companies providing training, support and mentorship around pitching skills, defining value propositions, capability gaps and opportunity awareness. In 2019/2020 the goal is to seek additional funding through other state and local government bodies to expand this program nationally.

Clusters

As a part of the continuing successful collaboration between METS Ignited and the Queensland Government, the Bowen Basin Cluster Program was launched in late 2017.

This secured a modest amount of project funds to support cluster-centric collaborative projects in the region. The seeding initiative provided \$0.5m of Project Funds to seed 4 projects to establish the basis for this regional cluster. With the appointment of a Cluster Development Manager, in 2018/2019 there were three METS Industry Clusters established.industry opportunities.

- Digital and Data Analytics Cluster is a group of approximately 25 member companies with a mission to facilitate collaborative opportunities and strengthen the digital ecosystem to enable the conversion of data into knowledge and value.
- Tailings and Mine Affected Waters is a strong group of over 30 members with the goal to develop and promote innovative and commercial solutions for tailings and mine affected water globally.
- Robotic and Automation—this is a highly active and self-sustaining cluster that has already engaged with a range of internation clusters in the same area. This group has over 35 members and is working across industry sectors including Oil and Gas, Space and Agriculture.

As the new Cluster Development Manager gains traction, we are seeing engagement with the SME Export Hub initiatives as a catalyst for further collaboration activities over the next year.



International Markets

With Australia's strong international reputation as a global hub for Mining Technology and Innovation, the goal of the International Markets initiative is bringing together opportunities available to reach international markets, through a range of flexible programs linked to companies, industry, or markets needs—helping Australian METS companies accelerate and grow into global mining hubs.

With the appointment of an International Markets Leader late in 2018, METS Ignited has established a range of services and support programs to help provide Australian METS companies with the opportunity to explore international markets at every stage of their organisational maturity. From access to market research, Trade Missions, Landing Platforms and access to Collaborative International Industry Groups. Today METS Ignited has established a series of programs including working with Expande Open Innovation Program, working with the Chilean METS sector for collaboration/partnerships taking advantage of the Free Trade Agreement (FTA) that eliminates all tariffs (since 2015). In Canada it has engaged with CEMI and potentially extending to CMIC, NORCAT, SAMSSA on the back of the FTA with Canada in force since 2018.

Locally, METS Ignited is collaborating with the local industry partners and membership organisations who also offer a range of different services including Austmine, Austrade, Trade and Investment Queensland, Export Finance Australia, Export Council of Australia to name a few.

Operational Update

As METS Ignited moves into delivery mode, the shift from stategy development to execution has resulted in some changes to the organisational structure. Included in these changes are the appointment of a dedicated International Markets leader and Cluster Development Manager, as well as changes to the leadership team structure and priorities. Looking ahead to FY2020, the organisation has dedicated resources to its key strategic objectives – with focus and speed the priority.

Collaboration is not only critical for the success of the METS Sector, but instrumental to the success of the growth centre. In living the values of collaboration METS Ignited has further strengthened its working relationships with the various industry associations and government departments, membership organisations, and regional industry networks. It is this network of aligned industry representatives that provides a platform to improve the regulatory environment with which we all operate. Certainty and consistency in all aspects of regulation requires a productive ecosystem to provide advise, direction and support.

During FY2019, METS Ignited continued to drive engagement with the research community, providing significant support for the Future Battery Industry (FBI) CRC, SmartSat CRC and the CRC for Achieving Sustainable Mining Closure.



Operational Update

METS Ignited also provided support for twenty-two CRC-P reviews during FY2019, with over half of these engagements prior to application, seeking guidance on potential industry participants, industry meetings, and recommendations on potential pathways to commercial scale should the research outcomes be very positive. Furthermore, METS Ignited was engaged in 6 ARC ITRP Applications, including Training for Advanced Practice's in OHS, The Future Mining Hub, Centre for Advance Manufacturing and Smart Mining and Data Analytics for Resources and Environments to name a few.

The support provided included engaging with METS and Mining industry participants, introductions where appropriate, facilitation of meetings or workshops with industry, and pathways to commercial success both in Australia and internationally. More broadly, Ian Dover presented at ARC-organised events and various universities on industry opportunities and challenges as well as how to engage with METS and Mining companies to develop pragmatic, attractive industry-oriented research proposals. These presentations have clearly had a positive impact in that the "commercial-industrial" quality of the most recent round of applications has substantially improved over those presented at the beginning of the growth centre.

With a major review of the Sector Competitiveness Plan scheduled for FY 2020, and as the outcomes from all of the hard work and dedication of the METS Ignited team past and present becomes apparent, we are certainly looking forward to an exciting year ahead.

Growth Centre Sustainability

METS Ignited continues to add significant value to the METS Sector.

Industry investment continues to be accessible to the growth centre and sustainability beyond the current funding model includes a range of scenarios, from cluster program administration, supply chain innovation projects – end market (Mining) funded project challenges and related collaboration investment opportunities. Discussions are also underway with various state government and other regional centres and membership organisations on what future operating models for the growth centre may include. In FY 2020 a formal sustainment plan will be completed with a range of business model scenarios submitted to the board for consideration.
